## Overview

BH Macro Limited ("BHM") is a closed-ended investment company, registered and incorporated in Guernsey on 17 January 2007 (Registration Number: 46235). BHM invests all of its assets (net of short-term working capital) in the ordinary shares of Brevan Howard Master Fund Limited ("BHMF" or the "Fund"). BHM was admitted to the Official List of the UK Listing Authority and to trading on the Main Market of the London Stock Exchange on 14 March 2007.

FX: FX forwards and options

Commodity: futures & options on commodities including mining indices

Credit: corporate and asset-backed indices, bonds and CDS

Equity: equity markets including indices and other derivatives

Digital Assets: cryptocurrencies including derivatives

Discount Management: buyback activity or sales of shares

## Performance Overview

Gains from interest rate trading were partially offset by losses from equity and digital assets trading.

In addition, FX trading made a few basis points of gains while commodity and credit strategies generated losses of a similar magnitude. Within rates, roughly two-thirds of the gain came from directional and yield curve trading across the US, Europe, Japan and the UK, with the balance generated from volatility positioning in Japan, US and Australia. The small equity losses came from tactical trading in the US and Asia, while digital asset trading detracted as a result of the broad mid-month sell off. FX trading generated small gains across EM, but these were mostly offset by losses from DM trading.

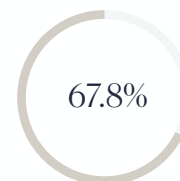
