BH Macro Limited ("BHM") is a closed-ended investment company, registered and incorporated in Guernsey on 17 January 2007 (Registration Number: 46235). BHM invests all of its assets (net of short-term working capital) in the ordinary shares of Brevan Howard Master Fund Limited ("BHMF" or the "Fund"). BHM was admitted to the Official List of the UK Listing Authority and to trading on the Main Market of the London Stock Exchange on 14 March 2007.

Performance Overview

Losses over the month came primarily from FX trading. Within FX trading, losses were relatively evenly spread between G10 currencies and EM, with the bulk of the EM FX trading losses coming from various Asian crosses. Interest rate trading generated a small positive return overall, with modest gains primarily from implied volatility and inflation trading strategies; directional and curve trading was virtually flat, with losses in the UK offset by gains in the US. Digital asset trading was a small detractor.
