Overview

BH Macro Limited ("BHM") is a closed-ended investment company, registered and incorporated in Guernsey on 17 January 2007 (Registration Number: 46235). BHM invests all of its assets (net of short-term working capital) in the ordinary shares of Brevan Howard Master Fund Limited ("BHMF" or the "Fund"). BHM was admitted to the Official List of the UK Listing Authority and to trading on the Main Market of the London Stock Exchange on 14 March 2007.

Performance Overview

FX and rates trading drove returns over the month with further smaller gains from equity trading and losses from commodity and digital asset trading. Within the rates complex, direction and curve trading was flat overall as gains from US, Europe, UK and EM markets were offset by losses from JPY. Additional interest rate gains were generated across European government bond macro-RV trading, inflation and volatility. FX gains stemmed primarily from JPY, EUR and CNH positioning while equity gains came from directional trading of DM indices. The broad sell-off in digital assets detracted somewhat with further very small losses from commodity trading in precious and base metals.
